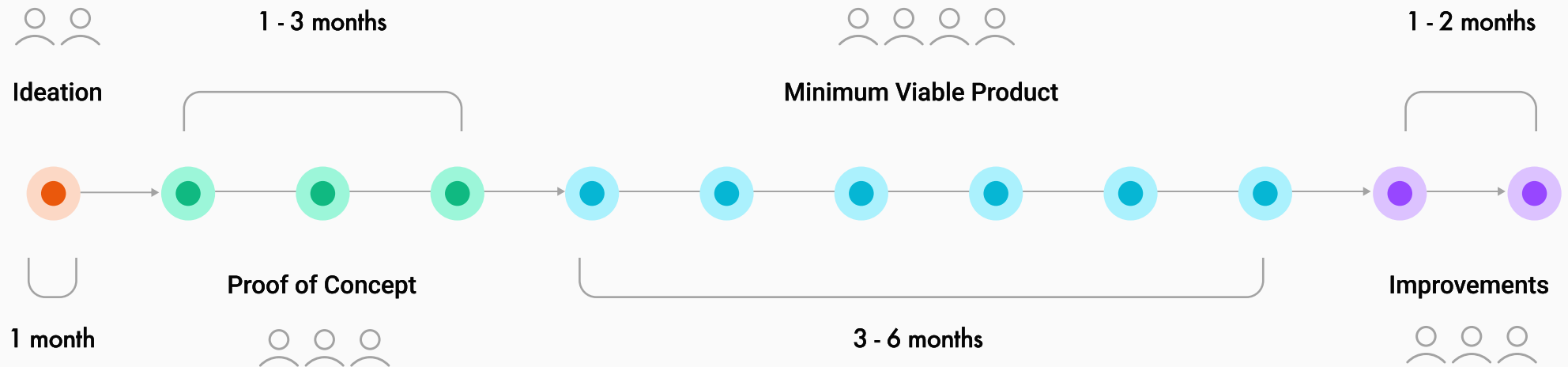
Phases and Tailored Approach

End-of-Life Management: As projects conclude, we either downscale entirely or transition seamlessly to client management.

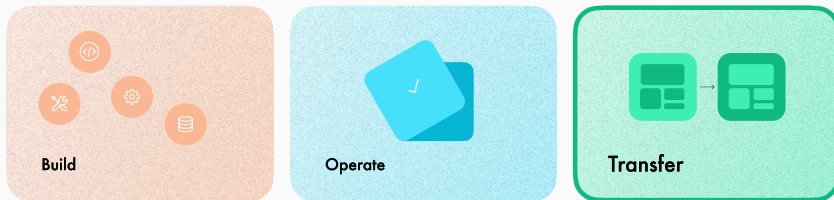
